

Membership

During the current year (2023) the number of membership of AFST (I) stands at **5127** out of which **4189** are life members (including Fellow).

Credential Committee: The Credential Committee met in the current year to scrutinize the applications received (462 new applications) for various categories of membership. Due to the life membership offer, there was a remarkable increase in the number of life membership applications this year as well. The Credential Committee did a wonderful job expediting the clearance of the application forms.

Life membership drive: Based on repeated requests from various chapters and members, the CEC advised taking up a Life Membership drive during the current year. The life membership offer was made available from **May 23, 2023** to **November 15, 2023** information about the membership drive was hosted on the AFST (I) website for wider dissemination.

Welcome Kit for Life Members: The Welcome Kit provided to Life Members consists of a Lapel pin, Tie, Pen drive with pre-loaded AFSTI content, Mouse Pad, and a Touch pen. This gesture from the CEC was widely appreciated by the members and is seen as a welcome step for attracting new Life members.

Finance Committee: The Finance committee met to discuss the Budget and Financial Status of the AFST(I). The committee made the following suggestions:

- Dr. Suresh D Sakhare, Hon. Secretary informed that, the company supporting the 9th IFCoN 2023
 with good sponsorship would have their advertisement featured in IFI Mag for the current year
 (Package).
- IFI Mag hard copy will be issued only to Life Members. The digital format (Soft copy) will be given to Student members.
- Hon. Treasurer informed that the Chapter share for the year 2021-22 has been paid to those who
 have submitted audited reports.

Website Committee: The major initiative was taken by the website committee to develop portal for online election of chapters, which was made under One organization One website initiative. The Demo Election for chapters (Aurangabad) was conducted successfully and it was suggested that from the next year the chapters could make use of the same platform. The Application Software (MIS) has been made ready and implemented and AFST (I)-HQ offices and Chapter's LEC online election platform is implemented for the live portal. The following procedure was followed for live elections:

- Communication to all chapters of AFST(I) regarding the rules to conduct online elections for various offices of their chapters was sent on August 28, 2023. Chapters were advised to send the notification and calendar of events for their chapters for uploading into the AFST(I) election portal.
- Online Elections for the following chapters of AFST(I) for the year 2024 was held from August 2023 to October 2023. Aurangabad Chapter, Vallabh Vidyanagar Chapter and Rourkela Chapter followed and successfully conducted the Online Elections.
- Guidelines and procedures were provided to all AFST(I) chapter to schedule the calendar of events for the online elections. The calendar of events provided by the chapters were uploaded on to the Election portal of AFST(I).

Building Committee: In order to obtain an alternate site, a lawyer was hired for legal consultation. MUDA allotted an alternative site with number 173 at JP Nagar, measuring 215.62 sq m. The new site is 74 sq m larger than the original site. Hence, MUDA requested that the difference amount to be paid be as per the 2023 MUDA rates. However, the AFST(I) office, with the lawyer, justified that MUDA needed to consider the difference amount as per 2019-20. The request letter was approved by MUDA, and the alternate site was issued with the 2019-20 price. This was consulted by MUDA with their legal team, and our request was approved. These efforts saved a large amount for AFST(I). As per the requirement of MUDA, the previous documents pertaining to the original sites were submitted. The difference amount was paid from DJBF, and the allotment letter was issued in the name of Dr. Inamdar AA, which would subsequently be transferred to AFST(I).

However, to save on double registration charges, a request was made to Chairman, MUDA, to issue the allotment letter directly in the name of Hon. Secretary, AFST(I), with written consent from CEC. MUDA agreed to the same, and the site has been allotted in the name of Hon. Secretary, AFST(I).

Awards Committee: The award committee met several times to scrutinize and consolidate the suggestions received from Experts Panel and forwarding them to the CEC. The screening committee was nominated for evaluate the applications and nominations received for various AFST(I) awards as per the guidelines. The Award committee submitted the scrutinized list to the CEC for further finalization of the awardees.

Industrial & Government Relations Committee: The Industrial Relations Committee met during the year to discuss how to strengthen the industry – academia gap. Based on discussions with Government relation committee it was decided to conduct a workshop where academicians, industry representative and govt officials would be invited for panel discussion.

Student Committee: Under the supervision of the Students' Committee of AFST(I), a webinar on the topic "Secrets of Recruitment!" was organized by Ms. Chinmayee Deulgaonkar, Managing Director of Food Chain ID India, on September 02, 2023. The event was attended by approximately 155 students, CEC members of AFST(I), and members of the Students' Committee. Dr. R P Singh, Chairman of the Student Committee of AFST(I), extended a warm welcome to all the speakers and participants. Ms. Chinmayee covered the topic on the Secrets of Recruitment, encompassing several key aspects, including choosing a job application, tailoring CVs, understanding the job role, workplace culture, attitude, improving soft and hard skill sets, networking, and ways to express ideas and interests. She also shared her experiences with participants, narrating her journey from the beginning until today. The question-and-answer session was skilfully moderated by Dr. Usharani Dandamudi. Dr. Tanaji G Kudre, Hon. Treasurer of AFST(I) and Convener of the Students' Committee, expressed gratitude with a vote of thanks.

II. E - Election:

Shri B Vasu was nominated as the Returning Officer for the current year's elections of AFST (I) -HQ and Central observer for Online Election of Chapters. The results of the election will be announced officially in the AGBM as per the notice of the Election & AGBM.

III. Annual Convention and other activities at Headquarters:

The CEC decided to organize 9th International Food Convention [IFCoN], AFST(I) with CSIR-CFTRI, DRDO-DFRL and CSIR-IITR as co-organizers during 7-10th December 2023 in Mysuru on the Theme "TRIMSAFE – Technology Re-engineering for Innovation and Mitigating the risk for a Safe, sustainable Affordable & secure Food Eco-system". DSIR, FSSAI, IPFT and KSOU agreed to be Supporting partners for the event.

The Logo and theme contest for selecting Logo for 9th IFCoN was arranged for Students and PhD Research Fellows both for members as well as non-members. Many appreciations was received, and the expert team scrutinized the entries and selected a logo for adoption with the required modification. The winner will be conferred with a suitable memento, certificate, and free registration for the Conference.

A contest to select the logo for the 9th IFCoN was organized for both students and PhD research fellows, which was open to both members and non-members. Numerous applications were received, and the expert team reviewed all entries, ultimately choosing a logo for adoption with the necessary modifications. The winner will be honoured with a memento, a certificate, and complimentary registration for the conference.

An exclusive website for IFCoN (<u>www.ifcon.org</u>) is maintained for the registration of delegates with an abstract and poster submission portal. An IFCoN App is also functional for all the users and there will be 98 speakers and 24 sessions.

INDEPENDENT AUDITORS' REPORT

To the Members of ASSOCIATION OF FOOD SCIENTISTS AND TECHNOLOGISTS (INDIA)

Opinion

We have audited the Standalone financial statements of ASSOCIATION OF FOOD SCIENTISTS AND TECHNOLOGISTS (INDIA) ("The Association") which comprises the Balance Sheet as at March 31, 2023, the Statement of Income and Expenditure and the statement of Receipts and Payments, for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements give the information required by the Karnataka Societies Registration Act, 1960 (The Act) in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Association as at March 31, 2023, and **Surplus f**or the year ended on that date.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified by the Institute of Chartered Accountants of India. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Those standards require that we comply with the ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Financial Statements are free from material misstatement.

We are independent of the Association in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter

We draw attention to note # 6-Schedule-11- Notes on Accounts & Accounting Policies forming part of the Financial Statements. The Association's Financial Statements includes Audited financial statements of chapters, audited by other auditors. The Association comprises of 46 chapters/branches, out of which financial statements/reports of 33 branches audited by the other auditors have been included in the consolidated financial statements. However we have not received any financial statements (audited/unaudited) /audit reports/information regarding the rest of the 13 branches. Accordingly, we are unable to comment on such accounts.

The Turnover and the Input Tax Credit (ITC) as per GST portal and the books of account is under reconciliation and is subject to recording of entries, if any, on such reconciliation. We are unable to ascertain its impact, if any, on the financial statements.

Our opinion is not modified in respect of the above matters.

Responsibility of Management for the Standalone Financial Statements

The Association's Management committee is responsible for the matters stated in the applicable Law with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance, of the Association in accordance with the accounting principles generally accepted in India, including the accounting Standards specified under the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Association and for preventing and detecting frauds and other irregularities; selection and application of appropriate implementation and maintenance of accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

The Management committee is also responsible for overseeing the association's financial reporting process.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.

- b) In our opinion proper books of accounts as required have been kept by the Association so far as it appears from our examination of those books.

Accounting Policies

- 6. The Financial Statements includes Audited financial statements of chapters, audited by other auditors. The Association comprises of 46 chapters/branches, out of which financial statements/reports of 33 branches audited by the other auditors have been included in the consolidated financial statement. However no financial statements/audit reports/information regarding the rest of the 13 branches have been received.

MINUTES OF THE MEETING

The Special General Body Meeting (SGBM) of AFST(I) was to be held on 09th July 2023 in Southern Star Hotel, Mysuru at 12.00 Noon. However, the meeting was delayed by about 15 minutes and hence, the Chairman adjourned the meeting and requested the general body to assemble back at 12.30. The meeting was attended by 108 members and hence had the quorum required as per the constitution.

Dr N Bhaskar, President of AFST(I) and Chair of the SGBM welcomed the gathering of members and requested Dr Suresh D Sakhare, the Hon. Secretary to take the agenda forward. The Hon. Secretary placed before the GBM the agenda circulated amongst the members and also projected the same before the members. Some of the members requested the Hon. Secretary to explain the rationale for the proposed amendments. During this, the President also contributed and mentioned the chronology as to how the proposed amendments were deemed necessary. He also explained to the SGBM that as per the bye-laws, "any inclusions / modifications of bye-law must pass in two general body meetings" and after this SGBM the same would be again before the AGBM to be held during the International Food Convention (IFCoN) at Mysore.

After due deliberations and discussion among the gathered members, the SGBM unanimously agreed that the following texts shall be inserted under Section 3.8 of the constitution and the same would be circulated again as an agenda item in the upcoming AGBM.

- (a) To contest for the position of **President Designate-HQ**, the interested candidate(s) should be a life member of good standing for **10 years** with an equal amount of professional experience in the field of food science & technology and allied fields.
- (b) To contest for the position of **Vice president HQ**, the interested candidate(s) should be a life member of good standing (from HQ area) for **5 years** with an equal amount of professional experience in the field of food science & technology and allied fields. Eligible members from **HQ only will vote**.
- (c) Similarly, to contest for the position of **Vice President (Chapters)**, the candidate(s) should be a life member of good standing for **5 years** with an equal amount of professional experience in the field of food science & technology and allied fields.
- (d) To contest for the position of **Honorary Joint Secretary**, the candidate should be a life member of good standing for **5 years** with an equal amount of professional experience in the field of food science & technology and allied fields.
- (e) To contest for the position of **Honorary Treasurer**, the candidate should have been a life member of good standing for **3 years** with an equal amount of professional experience in the field of food science & technology and allied fields.

The SGBM ended with thanks to the Chair and all the members.
