Membership

During the current year (2024) the present membership of AFST (I) stands at **5030** of which **4433** are life members (including Fellow).

Life membership drive: Based on the repeated requests from various chapters and members, the CEC advised to take up a Life Membership drive during the current year. The information about the membership drive was hosted on the AFST (I) website for wider dissemination of the information.

Finance committee: The Finance committee met to discuss about the Budget and Financial Status of the AFST(I). The important suggestions are mentioned as below:

- Hon. Treasurer informed about Chapter share 2022-23 paid to those who have submitted audited report.

Website committee: The major initiative was taken by website committee to have Portal for chapters online election, which was made under **One organization One website** initiative. The following procedure was followed for live elections:

- Communication to all chapters of AFST(I) regarding the conduct of online elections to various offices of their chapters was sent. Chapters are advised to send the notification and calendar of events of their chapters for uploading into the AFST(I) election portal.
- Guidelines and procedures were provided to all AFST(I) chapter to schedule the calendar of events for the online elections. The calendar of events provided by the chapters were uploaded on to the Election portal of AFST(I).

About 40 Chapters were followed online Platform Elections under the One Association One Website and successfully conducted the Online Elections.

In the progressive journey of IFI Mag, the benchmark of the publications has been well recognized, wherein (i) Titles of published articles of IFI mag are indexed in FSTA and (ii) Complete published articles of IFI Mag are indexed in EBSCO science platform. A very recent benchmark is the granting of the International Standard Serial Number (ISSN) for the print publication IFI Mag. At present, IFI Mag is in the process of applying for UGC recognition through UGC-CARE web portal.

Awareness Training on Food Safety and Hygiene Auditing

Objective of the Programme: To explore various opportunities in food sector and create awareness on Food Auditing Practices

Salient features of the Programme: The Department of Food Processing Technology in association with AFSTI – Coimbatore Chapter has conducted awareness training on 11th September 2024 at 2 pm. Mr. Hussain Batcha S, FSSAI Empanelled Hygiene Rating Auditor and Food Safety Auditor from TAK SFS Private Limited, Trichy, delivered an insightful awareness session on Food Hygiene Auditing. Mr. Hussain specializes in conducting audits for food businesses across India. Mr. Hussain outlined the qualifications and responsibilities required for becoming a FSSAI empanelled Hygiene Rating Auditor (HRA). Ms. Tammana Farhat, an alumna of our department, shared her inspiring journey to becoming a Lead Auditor.

Mr. Hussain Batcha mentioned that candidates must have a relevant Bachelor's degree and possess specialized knowledge in food safety and hygiene and at least 30 man-days of audit experience in the food service sector. Furthermore, auditors must complete a mandatory FoSTaC Training in advance manufacturing by FSSAI. He stated the auditor must be renewed the certification after 2 years to ensure that they are updated with current food safety standards and practices. He also explained the FSSAI hygiene rating checklist, which ensures that food establishments meet hygiene and safety standards. The checklist include: maintaining clean premises, proper storage and handling of food to prevent contamination, and good personal hygiene practices by staff. Equipment must be properly cleaned and maintained, and food preparation areas must be sanitized with effective waste management. He stated that accurate documentation of hygiene practices and Personal training is crucial to accomplish outstanding hygiene rating. Mr. Hussain showed the hygiene check list of some restaurants that he audited for better understanding. His detailed explanation of the FSSAI hygiene rating checklist highlighted the importance of maintaining high standards of cleanliness and safety in food establishments. 37 students from II M.Sc Food Technology Management participated in the programme.

Mr. Basavaraj trained from Makeintern started his first session with introduction about GMP and PRP in the food industry and gave on overview on Global Food Regulatory authorities. In the afternoon session, he delivered a lecture on ISO, FSMS principles, types of audits and audit requirements. Second day forenoon session of the training was about HACCP and FSMS plan. Students were grouped into four and assigned with a task of HACCP plan preparation for their products. Subsequently, each group presented their HACCP plan to the Trainer. Participants from I M.Sc. Clinical Nutrition and Dietetics, I M.Sc Food Technology Management and B,.Voc Food Processing Technology attended the training programme in two batches and they felt the training session was very informative and interesting. Five Students from each the batches were selected for the second level of Zonal championship programme to be held at IIT, Hyderabad.

Hands on Training on Fermentation Techniques

Objective of the Programme: To equip students with practical skills in wine-making and fermentation techniques, while also enhancing their scientific and technological knowledge.

Salient features of the Programme: Department of Food Processing Technology and Association of Food Scientists and Technologists (India), AFSTI – Coimbatore Chapter organized one-day Hands-on Training on Fermentation Techniques for II M.Sc. Food Technology Management Students on 28th September 2024 led by Mr. Basavaraj Meti, Trainer, Makeintern, New Delhi. Mr. Basavaraj is expertized in Food & Beverages, Milk and malt-based products, Food Safety and Regulatory Compliance. The session combined theoretical instructions with practical session on preparation of wine from grapes, bananas, and pineapples and evaluated key quality parameters. He demonstrated essential steps in quality wine production, including importance of controlling temperature for fermentation. The training explored the flavour and aesthetic enhancement of wines by adding ginger, lime, cinnamon, and cloves. Students performed analysis including

Total Soluble Solids (TSS), pH, and Total Plate Count (TPC) of the wine before and after the addition of yeast, allowing them to understand the biochemical changes that occur during fermentation. The students are instructed to monitor pH and TSS change during the fermentation period of 10 days. This Training fostered a deeper understanding of fermentation techniques practiced in the food processing industry.

Day 2 - Role of management in Food Safety Management Systems (FSMS), Traceability in the food supply chain, global food regulatory authorities and CAPA (Corrective and Preventive Action) reports.

Day 3 - FSMS and Quality Management Systems (QMS) and role of Food Safety and Standards Authority of India (FSSAI) in outlining the key requirements that food businesses must adhere to for compliance.

This training fostered a deeper understanding of effective implementation of food safety practices in the food industry and the role of global food regulatory authorities in public health protection.

Every year, billions of tons of food are wasted—thrown away, spoiled in transit, or lost in supply chains. This not only represents a colossal waste of resources but also means that millions of people are being deprived of the food that could otherwise nourish them. We need to change the way we think about food—from a disposable commodity to a precious resource. For examples 74 to 78.5,000 Million tons of food is being wasted every year in India which equals 1 Trillion Dollars. Which is 8% of total production. Cautioned the student we are not only wasting the food but also wasting resources used to grow the food.

Opinion

Emphasis of Matter

We draw attention to Schedule-11- Notes on Accounts & Accounting Policies forming part of the Financial Statements. We also draw attention to our comments in our Report in Form 10BB dated 26.09.2024 under the Income Tax Act, 1961. The Association's Financial Statements includes Audited financial statements of chapters, audited by other auditors. The Association comprises of 46 chapters/branches, out of which financial statements/reports of 30 branches audited by the other

auditors have been included in the consolidated financial statements. However we have not received any financial statements (audited/unaudited) /audit reports/information regarding the rest of the 16 branches. Accordingly, we are unable to comment on such accounts.

The Turnover and the Input Tax Credit (ITC) as per GST portal and the books of account is under reconciliation and is subject to recording of entries, if any, on such reconciliation. We are unable to ascertain its impact, if any, on the financial statements.

Our opinion is not modified in respect of the above matters.

Responsibility of Management for the Standalone Financial Statements

The Association's Management committee is responsible for the matters stated in the applicable Law with respect to the preparation of these standalone financial statements that give a true and fair view of the financial position, financial performance, of the Association in accordance with the accounting principles generally accepted in India, including the accounting Standards specified under the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Association and for preventing and detecting frauds and other irregularities; selection and application of appropriate implementation and maintenance of accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statement that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

The Management committee is also responsible for overseeing the association's financial reporting process.
