# APPLICATION/NOMINATION INVITED FOR AWARDS OF AFST(I) FOR 2024 & AWARD OF SCHOLARSHIP OF AFST(I) EDU. PUBLICATION TRUST FOR 2024-25

Applications/Nominations for the following awards of the AFST(I) for the year 2024 are invited. AFST(I) members / Central Executive Committee/ Local Executive Committee can also nominate eminent persons for the awards. CEC/LEC members of AFST(I) are not eligible to apply for the award during their tenure period. Further, those who have already received an award of AFST(I) under a category cannot apply for an award in the same category. Fellow and Prof. V Subrahmanyan Industrial Achievement are the top awards of AFST(I). Generally, application from any person who already is a Fellow of AFST(I) will not be considered for the Prof. V Subrahmanyan award and vice-versa. The awardees will be selected based on the prescribed score card that will be evaluated/verified by a committee duly constituted by the CEC of AFST(I).

# General conditions in additions to those specified for each award

- 1. All the award applications are open only to Indian citizens or Indian citizens who are currently living / working abroad, unless otherwise specified. Award is granted for the work carried out in India, except in case of the AFST(I) Fellow Award & V Subrahmanyan Industrial Achievement Award, wherein work carried out abroad will also be considered for evaluation.
- 2. An individual or group can make an application / obtain nomination for **only one award**. However, one can nominate different individuals for different awards, if eligible.
- 3. Fellow of AFST(I) and Prof. V Subrahmanyan Award being the highest award of the association, those who are already awarded any one of these two shall not be eligible for any category of award except for AFST(I)-FSSAI award.
- 4. Any AFST(I) awardee in the past three years are not eligible to apply for any awards i.e., those who have received any AFSTI award (except for AFSTI trust scholarship) in 2023, 2022 & 2021 are not eligible for applying to any AFSTI award for the year 2024.
- 5. Applicants may go through the check list of documents and formats before filling their on-line application. No hard copy of the application will be considered. All the applications are to be submitted on the dedicated online platform of AFST(I) Awards. AASMaAn portal in AFST(I) web page Link available in www.afsti.org/awards
- Applicants are advised to carefully go through the Instructions before filling the Forms and keep all the required documents ready in the soft form so that delay/inconvenience can be avoided while submitting online.
- 7. The period for consideration of AFST(I) Awards for 2024 is **January 1**, **2024 to December 31**, **2024**.
- 8. Canvassing in any form and / or bringing any influence will lead to the disqualification. The decision of the duly constituted committee by the AFST(I) CEC, ratified by CEC is final.
- 9. Since the submission is on the online mode, applicants are advised to obtain the nomination letters in advance, scan the same as PDF and keep them ready to avoid last minute rush.
- 10.All Nominations / Applications along with appropriate supporting documents compulsorily should be submitted by Online AASMaAn web portal link available: **www.afsti.org/awards** on or before 5.00 PM on 20<sup>th</sup> November 2025.

#### Fellow of AFST(I)

The association confers "Fellow of Association of Food Scientists and Technologists (India)" [FAFST] to person(s) who have made significant contributions to the progress of Food Science and Technology through research & development and education. The aim is to honour persons of outstanding merit who have contributed significantly in the field of Food Science /Technology including R&D, product/project development, transfer of technology and marketing. The merit of contribution will be the main criterion and the same will be objectively evaluated as per the scoring system available in Form A.

- a) Those who have already been awarded the Fellow award or the Prof. V Subrahmanyan Industrial Achievement Award cannot apply for this award.
- b) **Self nomination is not allowed**. Only those candidates who are nominated by the requisite number of members of good standing or required number of fellows of the AFST(I) will be considered.
- c) Applications / Nominations should duly be accompanied with associated documentary proofs as mentioned in Form A & Fellow Nomination Format.
- d) Among the Fellows to be nominated, 70% could be from among the AFST(I) members and remaining 30% may be from among non-members of AFST(I).
- e) A maximum of two fellowships will be awarded in an award year. However, the final decision lies with CEC.

# Nominations for Fellow of AFST(I):

- Central Executive Committee members/LEC of AFST(I) are not eligible to nominate for a Fellow.
- 2. The nomination should be proposed by 2 Fellows of the AFST(I) or by a Fellow of any other national academy (NAAS, NASI, INSA, NAS, NAE or NABS) along with a Life Member of AFST(I) of good standing. The nomination has to be made in the prescribed format of nomination. Any regular or life member of AFST(I) can propose the nomination for only one Fellow in a particular year.
- 3. The application should be made on the portal specifically available for the purpose of applying to AFST(I) awards.
- 4. It is advisable that the applicants keep every document ready before submitting applications online so that undue delay or glitches can be avoided.

#### Selection of Fellows:

The selection of the fellows is a two stage process. In the first stage the nominations will be submitted online and objectively (self) evaluated based on a scoring system in place. The candidates can note their score once they complete submission of all the documents. All the suitable and eligible nominations will be placed before the committee duly constituted by the AFST(I) CEC for verification of claims and comments on the technical/scientific quality of contributions. The recommendations of the committee will be considered by the

CEC by majority decision to finalize the names of Fellows for the award year. The decision of CEC in this matter will be final.

- Once recommended and selected as Fellow, the concerned Fellow will be conferred with a Citation at the time of the forthcoming AGBM or at any other suitable function of the Association, as decided by the CEC.
- The Association may invite a Fellow, to deliver special lectures in the area of their specialization either at the AGBM or any other function/events arranged by the AFST(I).

# Privilege of Fellow:

Any elected Fellow of AFST(I) enjoys the following privileges:

- 1. To add FAFST after their name as a short title.
- 2. To be present and vote at all general body meetings.
- 3. To propose or second and recommend the candidates for Fellow of the Association.
- 4. To receive gratis copies of one of the publications of AFST(I).
- 5. To be nominated to any committee of AFST(I) by the CEC
- 7. To offer papers and communications to be presented before the meeting of the Association.
- 8. The title will remain for life time of the member.

#### **Cessation of a Fellow:**

- 1. Any Fellow may resign from their title of the Association by signifying their wish to do so by a letter addressed to the Hon. Secretary, AFST(I), which will be placed before the CEC for acceptance.
- 2. If the Association comes to know of any activity of fellow, which is detrimental to the interest and well being of the Association, the CEC will have the right to withdraw the title.

# Prof V Subrahmanyan Industrial Achievement Award

   Processing Industry through their academic and industrial achievements.

The merit of contribution to the industrial development shall be the main criterion.

- d) The nominee / applicant should have **proven significant contributions** to the enrichment of Food Science / Technology and the development of agro-based food and allied industries in India including the field of education in the areas of food science, technology and allied fields.
